CARES Connection Program Tablets for Eligible Applicants Now Available!

As we battle COVID-19, social isolation can be a harmful result of the social distancing needed to maintain good health. Many in our community, especially elders and those with disabilities, have spent months separated from family, friends and the normal activities of their daily community life. Our CARES Connection program aims to combat the increasing isolation and insuing loneliness by offering connection through new tablets for applicants who have access to wifi connection at home or a safe community wifi location.

Clinch-Powell Resource Conservation & Development Council, Inc. is proud to partner with Fahe to **offer these tablets (at no cost)** to help keep our neighbors connected with children, grandchildren, doctors, neighbors and to encourage connection to their community.

By signing the attached questionnaire, the applicant agrees that: 1) they are eligible, 2) they give permission for an aide to complete and submit the application on their behalf (if needed), 3) they agree to provide feedback to Fahe and/or Clinch-Powell if asked on how the tablet helped them, 4) they agree to accept help from Clinch-Powell in setting up the tablet so that it is usable, and 5) they have access to or can use a safe community wifi location.

Neither Clinch-Powell nor Fahe will share your personal information without your permission.

Once we receive the questionnaire application and you are approved, we will assign a tablet to you and make arrangements to deliver the tablet.

APPLICATION DEADLINE IS NOVEMBER 20. Return this application via fax to 865-828-5212 or email betsy@clinchpowell.net or mail to our office (allow 7 days for mail). We will process applications in the order received. **Tablet delivery will begin November 23.**
